- ❖ Christine submitted public contact info for Homer, Seward and Valdez.
- ❖ Doug provided public contact info for Ketchikan
- ❖ John would do some Sitka work. Sean has a former sponsee in Sitka. Doug provided starter kit (Basic, It works, 5 white booklets, 5 ea ten of the IPs, and mtg readings) that Sean will mail. On list, Sean and John or co-sponsors.
- ❖ Whittier – not working out. Community falling down on their end. Shawn not responsive to Doug's msg.
- ❖ Whittier – Lots of discussion (a) bring mtg into Whittier if community is responsive or (b) post info on the Girdwood meeting (which is not a very good time for Whittier residents because they would have to spend night in Girdwood to attend it because of tunnel schedule).

- ❖ Libraries – we could provide a book to various libraries. Lou Ann is library point person. Also, libraries (some) have an annual spending budget.
- ❖ Budget – we need figure budget: materials for mailers including envelopes and IPs, stamps, phone cards (possibly), book budget. Starter kit package.
- ❖ Churches – will they post flyers?

- ❖ Groups could donate basic texts? Arlene said that Out and About would probably donate one.
