Living Clean update.

- Significant changes on Chapter one from fellowship feedback.
 - Most feedback and communication with fellowship on literature than any other literature project.

There has been a \$500,000 reduction in income @ WSO in the prior year.

- Translations approximately \$10,000 – 20,000 per Basic Text.
- Electronic versions of literature available on-line (PDF).

WSC ARD Report

WSO has a 5 step cost cutting plan. First step "1"= least cuts, with five the most drastic. We are on step two. Step five equals the only service provided would be literature production and distribution. WSO desires to stop the NA Way mailings to groups free of charge.

(Two nominees for each vacancy). For WB a 60% of the total ballots cast are required to be elected. Most votes for other positions.
