Our last meeting was on the Zoom Line 6/10/19

From Washington/Idaho RD:

"The motion: "WNIR adopt and financially support fellowship Development in Alaska region by approving a one-time contribution of \$1,349.90. On going support will be evaluated in the future." Since there was no mention of what it would be specifically spent on (either in the motion or the intent of the motion) I say no further action is needed. I will report at our next RSC that phone line for outlying communities was not utilized as hoped. So a projector and mics will be purchased."

There are currently 2 Zoom meetings per week. The outreach committee is not conducting either meeting since they both have homegroup members making them true NA groups.

Dennis updated us regarding the translations: Athabascan translation estimate \$1200-1500. Translator works in Fairbanks. Language is more difficult than Yupik. The Yupik translation was \$1200. Yupik key tags are being investigated. Sally Fanson helped with Yupik translation. Yupik translation has been reviewed by Mandy's friend (an addict) and was well-translated. Dennis is in communication with a guy at World Services to make sure we are doing it correctly. Tlingit translation is also being investigated. Bethel and Nome have some Yupik stuff. Bethel seems like a good place to go for in person outreach. There is a large mental health facility. Kip and Paul could go to Bethel. Dennis has a phone number for a contact to the villages (Chiefs Group, Association of Village Council Presidents). An NA member has Bethel. Paul and Kip are willing to go to Bethel. All are in agreement. \$780 for two people round trip to Bethel in September.

Contact Pius (he doesn't live there anymore). Calling the facility to get in. Pricing Airfare. Lodging. Present to Region. Figure out Material to put together. Put together a presentation.

We have Zoom Meeting flyers.

Work with Juneau through the Zoom Line. Should someone go there? Zooming the upcoming convention. Or other events. Let Juneau know. Kenai just did a hybrid Zoom Meeting.

We are still working to put together group starter totes and figure out where we can send them. Kip put together a list. World improved stater list. Let's put together a final list. Lets get ahold of a couple starter kits with a small amount of supplemental stuff we want to add.
