#### Hello Everyone

We held our first meeting on February 24<sup>th</sup> via zoom. In attendance Arlene, Shawn and myself.

Our first order of business was to create a vision statement for Outreach, which was approved and is now posted under the outreach banner on the <u>www.akna.org</u> website.

Secondly was to formulate our goals for the coming year.

- 1. Continue with translations. We currently have the Tlingit translation underway. Arlene has a friend in the fellowship that speaks Athabascan and she is working on getting that started. I am working with an Inupiaq teacher from Barrow on that translation. The costs of translation can be costly, so we are looking at ways to minimize that for the region. But in saying that we must make sure that the work we do on the translations is as professional as possible considering that these may become permanent pieces of NA approve literature.
- Trip to Bethel to help start an NA meeting. We have set the date for May 21<sup>st</sup> through 23<sup>rd</sup>. I have a quote for airfare of \$470.00 for two tickets as well as a literature order \$214.00 to take with us. Both Arlene and I will be going. On this trip we hope to sit and listen to them read the Yupik IP and report back to the world translation board and if all goes well it will then become NA approved
- 3. Shawn is working to get a member from Fairbanks to join the committee and to oversee outreach in the interior that are connected by the road system
- 4. To connect with the already established meetings in outlying areas and make sure their meetings are listed on our regional meeting schedule as well as offer any support we can to help the grow. After just one meeting we realized there is a large cost that comes with outreach so one idea that was put forward is to create a t-shirt to sale to raise money for future projects such as translations. Thoughts!

We will be creating a yearly meeting schedule for zoom and publish it on AKNA webpage as well as all minutes from out meetings.

We also have a topic to be discussed under new business.
